

NOTICE OF MEETING

CYPRESS FOREST PUBLIC UTILITY DISTRICT

The Board of Directors of Cypress Forest Public Utility District will hold a regular meeting on Tuesday, April 2, 2019, at 5:00 p.m., at Cypress Forest Public Utility District's Administrative Building, 16215 Champion Forest Drive, Spring, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments, including correspondence from residents.
2. Consent Agenda: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member or member of the public so requests, in which event, the item will be removed and placed on the Regular Agenda.
 - a. Approve minutes.
 - b. Financial and bookkeeping matters, including payment of bills.
 - c. Tax assessment and collection matters, including payment of tax bills.
 - d. Operation of District facilities.
3. Additional tax assessment and collection action items, if any, including delinquent tax collections, installment agreements, and items related to payment of tax bills.
4. Additional financial and bookkeeping action items, if any, including review of investments and budget items, and approve attendance at conferences or meetings.
5. Energy market update and electricity proposal from Acclaim Energy Advisors for electricity contract.
6. Proposed development project for the Raveneaux Country Club tract, including actions related to the implementation of the Development Agreement, Lease Agreement, and communication with tenant regarding maintenance of lease tract.
7. Development, management, maintenance, and operations of parks and trails, including development of park facilities and features, communications with Harris County representatives, including purchase offer, approval of proposals and service agreements, consideration of donations, grant applications, and accessibility options, and approval of installation of waterlines and/or taps.
8. Matters related to homeowners associations, including tree maintenance and irrigation projects.
9. Engineering matters, including:
 - a. Capital Improvement Plan.
 - b. Design of facilities, including generator replacement and electrical system upgrades at Water Plant No. 2 in the service area.
 - c. Approve plans and specifications and authorize advertisement for bids for construction in the service area.



- d. Review bids and award contracts, and authorize execution of letter financing agreements for projects in the service area.
 - e. Approve pay estimates, change orders, and final acceptance for construction in the service area:
 - i. Sanitary sewer collection line repairs in Champion Forest Sections One and Two, and Champion Drive trunk lines.
 - ii. Water line to serve commercial tract.
 - f. Status of Federal Emergency Management Agency reimbursement application for Cypress Forest Park drainage repairs.
 - g. Deeds, easements, consents to encroachment, and requests for utility commitment letters.
 - h. Annexation requests.
10. Project for conveyance of Champions Municipal Utility District's wastewater through the District's sanitary sewer facilities, including any amendments to:
 - a. Amended and Restated Joint Trunk Sewer Line Agreement.
 - b. Wastewater Transmission Agreement with Champions Municipal Utility District.
 11. Reclaimed Water Supply project, including reports, proposals, agreements, and/or easements related to design of the District's proposed storage and distribution facilities, if any.
 12. Operations of Kleinwood Regional Wastewater Treatment Plant and the Kleinwood Joint Powers Board meeting.
 13. Hurricane Harvey related matters, if any, including status of District facilities and operations and applications for financial assistance, and approval of related proposals and agreements.
 14. Additional District facility operations action items, if any, including:
 - a. Customer correspondence and billings.
 - b. Surface water and water quality.
 - c. Repair and maintenance items, if any, including meter replacement program, valve repairs, and manhole surveys.
 - d. Water accountability and analysis of water distribution costs.
 - e. Conduct hearing on termination of water service and authorize termination of service.
 - f. Adopt Amended Rate Order.
 15. Review Water Conservation Plan; approve annual report and water conservation implementation report on implementation of Water Conservation Plan; adopt Order Adopting Amended and Restated Water Conservation Plan.
 16. Review Drought Contingency Plan and Adopt Order Adopting Amended and Restated Drought Contingency Plan.
 17. Conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.
 18. Matters related to the North Harris County Regional Water Authority.
