- f. Status of Federal Emergency Management Agency reimbursement application for Cypress Forest Park drainage repairs.
- g. Deeds, easements, consents to encroachment, and requests for utility commitment letters.
- Annexation requests.
- 11. Project for conveyance of Champions Municipal Utility District's wastewater through the District's sanitary sewer facilities, including any amendments to:
 - a. Amended and Restated Joint Trunk Sewer Line Agreement.
 - Wastewater Transmission Agreement with Champions Municipal Utility District.
- 12. Reclaimed Water Supply project, including reports, proposals, agreements, and/or easements related to design of the District's proposed storage and distribution facilities, if any.
- 13. Operations of Kleinwood Regional Wastewater Treatment Plant and the Kleinwood Joint Powers Board meeting.
- 14. Additional District facility operations action items, if any, including:
 - a. Customer correspondence and billings.
 - b. Surface water and water quality.
 - c. Repair and maintenance items, if any, including meter replacement program, valve repairs, and manhole surveys.
